Medical Social Worker

- Assesses psychosocial needs
- Serves as a liaison between patients / families and community agencies

Nutritional Services

- Dietitians referrals available for nutritional counseling
- Diet planning for specific diet prescriptions

Eligibility

- Must be MEDICARE Certified
- Must be HOMEBOUND - this means that the patient must experience a taxing effort to leave the home, and absence from the home should be for short periods only and infrequent
- The care that the patient requires must be intermittent - this means that the care the patient receives must be more than one visit and a reasonable level of rehabilitation can be expected with treatment.
